RULES & REGULATIONS

ELIGIBILITY:

- * Contestant must be between the ages of 5-8 (age as of August 1, 2022).
- * Contestant must be a current resident of Wirt County or attending Wirt County Schools.
- * FORMER Wirt County Fair Little Mr. or Miss winners are ineligible to compete.
- * CURRENT title holders from other fairs or festivals are ineligible to compete.

{Please Note: Contestants may not compete for another title during their reign as Wirt Co. Little Mr. or Miss. Once an application has been submitted to the pageant committee, the contestant may not compete in another pageant prior to the Wirt County Fair Little Mr. & Miss Pageant.}

FEES: Each contestant is required to be sponsored by a Wirt County resident, business or organization, which is responsible for the entry fee of \$50.00. This entry fee is NON-REFUNDABLE and must be attached to the completed application at the time of submission. **NO APPLICANT WILL BE CONSIDERED AN OFFICIAL CONTESTANT WITHOUT A COMPLETED, SIGNED APPLICATION AND THEIR ENTRY FEE.**

ENTRY DEADLINE: No contestant will be accepted into the pageant after the entry deadline of June 30, 2022. Absolutely no exceptions.

PAGEANT REHEARSALS: All contestants will be expected to attend pageant rehearsals and no one will be excused without prior consent from the pageant director. Tardiness or failing to attend rehearsals may be grounds for dismissal from pageant festivities and directly impact your score. If you MUST miss a

practice or if you are going to be late, it is YOUR responsibility to call Jessica Shaffer at (614)-270-6570, (304)-373-6394 or

(681)-236-2113 to let her know you will not be attending and make arrangements to discuss what you miss during your absence.

CONTESTANT PRIZE PACKAGE: Each contestant will contribute items for contestant's prize package. If there are five contestants, we will put together seven prize packages. One for each contestant and one for the former Little Mr. and Miss. You will be asked to contribute 7 items which will be used to make up these packages. Items may include small toys, candy, bubbles, etc. Please do not bring any thing that cannot tolerate the heat...for example, no chocolates. Your sponsor may be able to help with this.

WIRT COUNTY FAIR LITTLE MR OR MISS **RESPONSIBILITIES**

Little Mr. or Miss of the Wirt County Fair will be expected to be present and accessible at the Wirt County Fair each day, and must be accompanied by an adult at all times. A schedule will be supplied by the pageant director with activities highlighted, that the little Mr. & Miss will be required to attend. It is mandatory that the Little Mr. & Miss are present at the LIVESTOCK SHOW, SALE, YOUTH GAMES, and other key events.

The Little Mr. & Miss are also expected to help put together the prize package for the next year's winners! It is their responsibility to gather items that will be used to create a gift package (of equal value to the one they receive) for next year's pageant winners.

You are welcome to attend parades, but you are responsible for all the fees and

arrangements and you must contact your pageant director prior to the parade.

We also urge you to attend other fairs and festivals as guest royalty.

THERE IS A MANDATORY MEETING TO GO OVER ALL RULES AND REGULATIONS. YOU WILL BE NOTIFIED OF THE DATE AND TIME OF THIS MEETING BY EMAIL OR BY PHONE. EACH CONTESTANT MUST BE ACCOMPANIED BY A PARENT OR GUARDIAN. I WILL BE TAKING A PHOTOGRAPH OF EACH CONTESTANT AT THIS MEETING.
